New: Gartner Magic Quadrant for CSP 2018

SER Group a Challenger in 2018 Gartner Magic Quadrant for Content Services Platforms

(11/06/2018 – Bonn) Gartner has positioned the SER Group as a *Challenger* in the newly published 2018 Magic Quadrant for Content Services Platforms (CSP)*. The SER Group, the only European ECM vendor among the Challengers, credits the positioning to its strong international market presence, clear vision and diverse product attributes.

Once again, the SER Group has been recognized in the Magic Quadrant — as a Visionary last year and now as a Challenger. "The SER Group, placed as a Challenger, is expanding its position among the international vendors that lead the content services market," explains Morad Rhlid, Managing Director of SER Solutions International GmbH, "The Challenger position in the upper left of the Magic Quadrant, as we see it, substantiates the growth targets we have reached and the perception of Doxis4 as an established global brand."
